1. Please ensure you have completed and returned a booking form specific for the Class or Course you are undertaking.
2. Your booking will only be confirmed once we have received full payment.
3. A place can be reserved for a maximum of 1 week but this must be agreed by the Office Manager.
4. Drop-in spaces (*classes and courses*) can only be booked up to 7 days in advance of the session date.
5. All international payments may be subject to a small processing fee levied by the bank and additional bank charges must be covered by the participant.
6. All international payment must be made in GBP.
7. Cancellation Policy;
 - i. A full refund will be given if a place is cancelled 2 weeks or more before the class or course begins or if it is cancelled due to unforeseen circumstances.
 - ii. A 50% refund will be given if a place cancelled more than 7 days before the class or course begins.
 - iii. No refund will be given if a place is cancelled 7 days or less.
 - iv. Class or course payments cannot be refunded or transferred once a class or course has begun.
 - v. The company reserves the right to cancel any class/course if necessary. You will be notified as soon as possible and a full refund or place on another class/course will be offered.
8. Please ensure you are on time and ready to begin prior to the start of the class or course.
9. All participants for any *adult aerial courses or workshops (only)* must be over the age of 16.
10. All participants for any *junior aerial courses or workshops (only)* must be between 6 – 15 years.
11. We reserve the right to refuse participation if we suspect any participant(s) are under the influence of non-prescriptive drugs or alcohol.
12. All participants of any *aerial class or course* must complete a disclaimer form prior to commencement.
13. Each participant is required to take part in the led 'warm-up' (*this is specific to an aerial course only*).
14. Latecomers will be admitted on the discretion of the teacher.
15. Participants must vacate the studio within 15 minutes of the end of class.
16. Please notify the Creative Coordinator of any medical reasons that may limit you from taking part in the class or course.
17. All participants must provide us with an emergency contact name and number on the registration form.
18. The Higher Space is used on a regular basis by individuals and visiting companies. Please do not use or tamper with any of the equipment unless instructed to do so.
